***Gyanodaya - Library : The Learning Resource Center***

Keeping in view the vision and mission of the Institute, Gyanodaya library has been established “to promote knowledge generation and application through its effective dissemination”. The library acts as the main learning resource centre and caters to the information needs of the Institute's teaching, training, research and consultancy programmes. Operating from a spacious building of about 2800 square meter, fully air-conditioned, centrally located and functionally designed building with a seating capacity of 250 readers in five halls, the library is equipped with ergonomically designed furniture, fittings and fixtures. Library has a unique collection of more than 46000 Books, 107 print and 4900 online reputed international and national Journals (with bound volumes) in various disciplines. Library also has a substantial collection of Databases, E-Journals and CD-ROMs.

**Timings**

In order to facilitate self-learning among students, library remains open round-the-clock, all days of the week, except Government Gazetted holidays. However, full range of services is provided from 09:00 to 17:30 hrs, whereas, circulation services take place up to 21:00 hrs only.

**Borrowing Entitlement**

The members can borrow documents as per the following norms:

Faculty: 30 books for 3 months, Research Scholars: 15 books for 1 month, PGP Students: 8 books for 15 days, Officers: 10 books for 1 month, Staff: 5 books for 1 month.

## Collection

**Books**

Library has acquired a collection of about 46,000 books on management, agriculture, social sciences and other allied areas. The collection is continuously being updated with latest titles of interest as scanned from a variety of standard selective sources. A selection of new acquisitions is displayed, for a week, in the entrance lobby, near the Reception Counter” and a monthly publication entitled “Current Additions” keeps the clientele informed about the latest arrivals. As collections are of various sizes and formats, most of them are kept on open shelves directly accessible to the users, while some rare items are preserved in closed stacks and made available only on request. The books are classified by “Dewey Decimal Classification” scheme. AACR2 is followed for cataloguing. Collection symbols are written at the top of the call number on the spine label of the document, e.g. R for reference, RA for rare, RE for report, T for thesis, H for Hindi books, CL for documents in children section etc.

The library is operating in a fully automated environment with a blend of conventional documents and human interface in its services. Integrated library management software-LIBSYS is in place. Entire library resources are bar-coded and an On-Line Public Access Catalogue (OPAC) is giving information about its resources. The active collection of the library is tagged with the RFID (Radio Frequency Identification) tags and the RFID System has been installed for surveillance, issue return and other operations.

CapEx is a database of investment projects that involve the setting up of new capacities. The name "CapEx" is a concatenation of the short-form of Capacity Expansion, and of Capital Expenditure.

An investment project involves some capital expenditure and it involves some capacity expansion. The CapEx database is about the announcement of such projects, their implementation and their final culmination into new capacities.

The CapEx database captures projects that entail a capital expenditure of Rs.10 million or more.

CMIE has been monitoring the creation of new capacities ever since it was established in 1976. The monitoring work started being databased systematically in 1996. The current CapEx database therefore contains information on projects since 1995-96.

The CapEx database records the progress in implementation of investment projects. The database is a lot more than a mere listing of projects.

The CapEx database captures new projects being announced, tracks the various events of the projects in its radar and captures the end of the project. The life-cycle of a project ends when the new capacity is created and deployed into production. Sometimes, the end is less rewarding. A project may get abandoned before its completion. Or, its implementation may get suspended because of some reason.

The CapEx database captures this life-cycle of projects. A useful derivative of the CapEx database is the set of aggregates that are generated using the project-level database every quarter. They include aggregates of the value of new investments or of the completion of projects during a quarter. These provide a time-series of the investment activity in the country and are therefore a useful set of macro-economic indicators of the investment cycles in the country. It provides a range of projections of new capacities expected in the near future. CapEx is about current investment projects to create productive capacities in the future.

### Consumer Pyramidsdx

**Monthly Expenses- Consumption Pyramidsdx** provides a detailed break up of the monthly consumption expenses of Indian households. The database contains data on 153 specific expense heads. Many of these are expense heads with further detailed expenses embedded. About a quarter of the expense heads are of food expenses. Others include clothing, footwear, cosmetics, toiletries, appliances, restaurants, utilities, transport, communication, education, health, EMIs and miscellaneous.

**Weekly Expenses-** This database also offers data on expenses incurred during a week on 33 expense heads. These are consumption goods or services on which expenses are made relatively more frequently and households have a better recall of these expenses. Weekly expense data is collected during every Wave and is available in the form of three snapshots corresponding to the three Waves in a year.

**Adjusted monthly expenses-** Monthly expenses are also collected for the expense heads for which weekly expenses are collected. These monthly expenses are available in the raw form in which they are collected and also in an adjusted form. The adjusted monthly expenses are derived using the weekly expenses assuming that weekly expenses are more reliable but, using the month-to-month variation seen in the monthly series.

**Household groups-** This data-set associates every household with five household groups. These groups are based on the composition of members of the households by four characteristics. These are age-composition of members, occupation-composition of members, education-composition of members and gender-composition. The fifth group is based on size, i.e. number of members in the household.

These sources bring the total records available in the database to more than 1.2 million.

### Economic Outlook

Economic Outlook provides CMIE's view on where the Indian economy stands and where it is likely headed. This view is derived from a careful and continuous monitoring of all new data releases.

Time-series analysis and an integrated view of the Indian economy form the core of CMIE's forecasts. Detailed and comprehensive statistical forecasts are presented in Economic Outlook every quarter.
